Most of the tour participants had read the article and made their plans accordingly. There was no publicity in the *StarTribune* or *Pioneer Press*.

The unsold books about Ralph Adams Cram, by author and architect Ethan Anthony, were returned to the publisher for credit. CGS has purchased a copy for the archives.

There was a discussion by the Board regarding future lectures. Due to the high cost of airfare and lodging, it was suggested that we think creatively and seek out local experts to speak to members and friends of the Cass Gilbert Society at future lectures. A committee was formed to begin the planning process. Committee members are: Marjorie Pearson, Nick Marcucci, Jean Velleu, Cindy Stephani, and Wendy Weimer.

It was moved to offer Brian Pease a complementary membership in the Cass Gilbert Society.
