Mary Beth Betts to Speak at Fall Lecture

Dr. Mary Beth Betts, Director of Research at the New York City Landmarks Preservation Commission, will speak at the upcoming Cass Gilbert Society lecture. Dr. Betts's talk, "Cass Gilbert's Architectural Aesthetics 1890-1934," will focus on the role of drawings in the Cass Gilbert office and how drawing shaped Gilbert's aesthetics during the course of his career.

Dr. Betts was architectural curator at the New-York Historical Society where she played a major role in cataloging, curating, and conserving the Cass Gilbert collection of drawings, blue-prints, photographs, and correspondence. In her current position, she has been involved in the ongoing preservation of major Cass Gilbert buildings in New York City. She has been a contributor to two recent publications on Cass Gilbert: Cass Gilbert, Life and Work: Architect of the Public Domain (W. W. Norton and Co., 2001), a collections of essays based on the



symposium "Cass Gilbert, Life and Work: From Regional to National Architect," held in New York City, November 1998, and *Inventing the Skyline: The Architecture of Cass Gilbert* (Columbia University Press, 2000), published in conjunction with a major exhibition of Gilbert's work at the New York Historical Society.

The lecture will be held at the University Club of St. Paul, at 7:00 PM, Tuesday, September 24, 2002. The Minnesota Humanities Commission sponsors the 2002 Lecture Series. Admission is free to members of the Cass Gilbert Society. There is a nominal charge for nonmembers.

Message from the President

To their credit they have talked about including all Minnesotans in the 100th Birthday Party. They hope to have the activities last a whole year and lead up to the one big bash at the Capitol. One inventive person suggested we have all young people draw straws to see who would win the opportunity to release an eagle from the Capitol steps! That's just one of the many good ideas. You will be hearing a lot more, so stay tuned. We are fortunate to have such a beautiful Capitol and have Cass Gilbert to thank for insisting every detail be right. A call and visit came from Richard Carlson representing St. Clement's church. He presented the Cass Gilbert Society with four prints of St. Clement's in a sepia tone suitable for framing. These were copies of original sketches done recently by an architect in their congregation and have incredible detail in both interior and exterior renditions. These have also been reduced to note card size and may be available for sale at our lectures. However, the real prize was a copy of a large original drawing which appears to be by Cass Gilbert's own hand. It is not signed and more research is needed but the early concept drawing had those familiar water color touches we all have seen on Cass Gilbert's work. This drawing will be presented to the Minnesota Historical Society for proper restoration and care. The church will maintain a copy. Richard hopes our history sleuths are able to confirm the artist as Cass Gilbert.

In early August a young woman named Ann Marie Alexander called from New York City. Ann Marie is the marketing person for a newly designated historic building at 130 West 30th Street (between 6th and 7th Avenue) in Manhattan. You guessed it! The building was designated a Cass Gilbert, so the new owner, who is converting the highly freized building from commercial to living spaces, wants to use Cass Gilbert Tower or Cass Gilbert Plaza for the name of the building. The 100,000 square foot space will be converted to 45 units and each new resident will be given a membership in the Cass Gilbert Society when they move in. When I told Ann Marie some of us were coming to New York in October she invited us to tour the new spaces. So we have

CASS GILBERT IN THE NEWS

The Star-Tribune reported on July 5, 2002, that Paul Clifford Larson discovered Gilbert had designed a short-lived baseball park with his partner James Knox Taylor. Built in 1888, it stood for a year or two at State and Eaton Streets on the West Side, before it succumbed to construction flaws and seasonal flooding.

The New York Times reported on August 24, 2002, that the New York City Opera, which is considering relocating from Lincoln Center to lower Manhattan, has been looking at the site of the Cass Gilbert-designed office building at 90 West Street. Heavily damaged during the World Trade Center attacks and still sheathed in a protective covering, the building is estimated to require \$50 million to \$100 million to restore. Apparently City Opera would construct a new facility on the site. Because the building is a New York City Landmark, any demolition proposal will require a series of public hearings and extensive review.
